# Education, Child & Youth Development



The core objective of the ESAF Balajyothi project is to assemble rural children by forming clubs and study centres and to improve their academic and non-academic performance.

#### **Target Beneficiaries**

Balajyothi Project is one of the Flagship projects of ESAF Society supported by ESAF Small Finance Bank CSR project. The Project envisions to organise rural children in the form of Clubs and Study centres to bring holistic development in children. During this year 41 new clubs have been formed in Kerala and Tamil Nadu, thus inducting 1,118 children into the programme. Presently 2,470 children are part of the Balajyothi project through 70 clubs and 34 study centres.

## Regular Club Activities 7

Balajyothi Project is reckoned for its dynamic actions and deliberations at the club level. Normally the children in the clubs meet monthly once and the studycentre extends academic support to the children on a regular basis. Every month, themebased sessions are organised for the children in different areas. The facilitators/ volunteers and the Balajyothi coordinators lead the sessions.

## Academic Support 🛛 🥆

Academic support for children is one of the focus areas of Balajyothi Project. The team has been providing tuition support to the children through the Balajyothi study centres. Balajyothi has 34 study centres through which children are provided tuition support and other academic guidance. 608

children benefitted academically through these study centres. The study centres were functional during the lockdown period also through online mode. The interventions of Balajyothi team through the study centres helped its members to secure high marks in the recent SSLC examinations.

## Training for Facilitators $\nabla$

Good teachers can guide the children effectively, the facilitators play the role of teachers in Balajyothi Study Centres. The knowledge upgradation of the facilitators is the

key to making the study centres dynamic. On this ground, the Balajyothi Project conducted two ToT programmes for the facilitators.

> A direct session was organized for the facilitators on innovative engagement with the children.

> 17 facilitators from different studycentres attended the one-day training.

> Dr. Jacob Samuel (Director and Co-Founder of ESAF) inaugurated the programme and Dr. Semichan Joseph (Assistant Professor-Bharatmata College) handled the session. Online sessions were also carried out for the facilitators to enhance and update their knowledge.





## Balajyothi Week 🔨



Balajyothi Week was celebrated in the month of November. Different activities were carried out in clubs with the support of bank officials. 60 children from Balajyothi clubs registered for the Online Quiz Competition and 32 children participated in the same. Children wrote letters to the Prime Minister of India on the theme 'India of my dream'.

Considering the holistic development of children, the ESAF Balajyothi team organized training sessions in different nonacademic areas such as drawing, craft making, and public speaking.

## Drawing Training (Varamozhi) 🗸

79 children from Kerala and 16 children from Tamil Nadu attended the training sessions. The training sessions covered basics of drawing, different patterns in drawing, doodle art etc. The training began in October 2021 and continued till

March 2022. Children learnt to draw pictures through the training and on special days they displayed their skills by drawing pictures and cartoons on the special day themes.

### Craft making (Nirmithi)



Craft making was another area the children were able to excel in, thanks to the initiatives of the Balajyothi clubs. Online sessions were organized to improve the craft-making skills of the children. 70 children from Kerala and 113 children from Tamil Nadu took part in the programme.

## Public Speaking (Vamozhi) 🗸



With the intention of developing and improving the oratory skills of the children, the Balajyothi team conducted public speaking training in Kerala and Tamil Nadu through online and offline modes. A total of 654 children benefitted from the public speaking training, out of which 389 children were from Kerala and 265 were from Tamil Nadu. After undergoing training in public speaking, many of the Balajyothi members were able to participate in public speaking competitions organised by their schools, various newspapers and the Balajyothi Clubs.

## Career Guidance 🔻

Career guidance training was given to the Balajyothi members in Kerala and Tamil Nadu. The training was aimed at helping the children set goals early on in life. Online and offline modes were adopted for the career guidance training and a total of 118 children benefitted from the programmes. In Tamil Nadu, two offline sessions (Minjoor & Kovalam) helped 39 children to receive career guidance with the help of social work students at Madras School of Social Work. In Kerala Students in 10th standard and above were the beneficiaries and 79 children from different clubs and study centres attended the session. Dr.Issac Thomas (National Level Trainer) was the resource person for the same.

## Adventure Camp 🔨

A paper-pen-making training was conducted for the facilitators and the volunteers under the Balajyothi Project. 29 facilitators and volunteers attended the training. The resourceperson explained the materials required and how to make the paper pen. The facilitators trained the children in their respective centres on paper pen making and all together the children made 15000 paper pens with a seed inside and that was distributed to various school children to build environmental awareness and each pen thrown out

## Regular Football Coaching

As part of Balajyothi Project, regular football coaching was provided to the children belonging to the CYRC (Child & Youth Resource Centre) at Don Bosco


College ground, Mannuthy. 71 children are receiving regular training with the support of two coaches.



### Leadership Development Programme $\nabla$



The Balajyothi team organised Leadership Development Training Programmes for moulding future leaders. Three training sessions were organised as part of the programme and 136 children benefitted from the same. Self-Awareness, Empathy, Team Building/ Critical & Creative Thinking, Decision Making, and Communication were the topics covered through the training programme.







#### Holiday Camps 🔨

Two holiday camps were organised during the Christmas Vacation for the children of CA High School, Ayakkad and Don Bosco College, Mannuthy. 72 children participated in the camp. In the camp, the children were trained in different

sports such as football, basketball, and badminton, and theoretical sessions were also incorporated into the training programme. Child rights, leadership, and communication were the themes broadly discussed in the camps.

#### Renovation of Playground abla



The renovated playground at M. M. U. P School was inaugurated by Shri. K. Paul Thomas (Founder -ESAF Group) on 23<sup>rd</sup> December at Pittukarikulambu. The playground was renovated with the CSR fund of ESAF SFB through Balajyothi-CYRC Project. The playground was blessed by HG Yuhanon Mor Melitius, Manager, M. M. U. P. School & the Bishop of Malankara Orthodox Syrian Church, Thrissur Diocese. Smt. Kavitha Madhavan, President of Kizhakkancherry Gram Panchayat was also present on the occasion.

#### Special Training

Special training programmes were organized for improving the academic performance of the Balajyothi members through the support of Tata TRENT. Special training programmes were carried out for learning maths through games, memory enhancement, and communicative English. The details of the training areas follows:

#### Learning Maths through Games

As part of the Balajyothi Project,10 training programmes were conducted in Thrissur District, on the topic of learning maths through games. Shri. Prasad K. C., Certified Management Accountant, trained the children. The two-hour sessions included lectures and learning activities. A total of 259 children benefitted from the training.

#### Memory Enhancement Training

The onset of the pandemic and the absence of physical classes affected the academic life of children. The Balajyothi team supported the children by helping them prepare for their exams through Memory Enhancement Training Sessions. The team conducted 10 training sessions in the Thrissur district and covered 205 children.

#### Communicative English Workshops

Communicative English Workshops were organized for the students of 10 Balajyothi Clubs. Self-introduction, basic grammar, phrases, and communication were the topics discussed in the workshop. Shri. Jerish L. was the resource person for these sessions. Children from 11 clubs participated and got benefit of the sessions.

## Case Studies 🔨

#### Case 1: A Blessing for the unreached

Mudicode Balajyothi Study Centre, Thrissur, is located by the side of an irrigation canal, in a bustling colony where the majority of the residents belong to the lower strata of society. For the residents, every day is a struggle to make ends meet; Government services and schemes seldom reach them and the children of the colony barely receive any academic aid. It was at this juncture that ESAF's Balajyothi centre shone like a ray of hope for the children of the colony.

The Balajyothi centre provided academic and non-academic support to around 20 students of different age groups in the colony. Anaswara E. S., a 10<sup>th</sup> standard student, was the smartest among all the students in the study centre.

Anaswara's family comprises her father, mother and two elder sisters. Her father is a daily wage labourer while her mother is a homemaker. Both her siblings are pursuing their education. The meagre income of her father was not even sufficient to meet the family's daily needs. Hence, attending private tuition was something Anaswara could only dream about. Despite their financial constraints, Anaswara's parents were desperately looking for a way to support her academic journey. Thus, in 2019, when they learnt about the launch of ESAF's Balajyothi club in their locality, they did not have to think twice about enrolling her.

The club brought out the best in Anaswara. She outshone her peers in academic as well as non-academic activities.

Last year, she was the only SSLC aspirant from the study centre and the facilitator gave her the privilege to attend special training. Her schedule was specially charted to make the best of her time. The facilitator increased the number of special academic sessions and decreased the frequency of non-academic sessions. Special classes in Maths, Science, English, and Social Studies were also provided to strengthen her subject knowledge.

Apart from subject-oriented training, she also underwent counselling sessions to improve her mental well-being and face the exams fearlessly. Prior to the public examination, the study centre also provided intensive crash training sessions, an hour in the morning and two hours in the evening, to deepen her proficiency in the subjects.

No wonder, Anaswara proved her mettle and came out with flying colours. Her perseverance paid off, as the bitterness of her hard work turned to sweetness when she secured A+ in all the subjects in the SSLC examination. Her parents were ecstatic when they saw the result. They thanked the study centre and were grateful for the support and guidance the study centre provided to Anaswara.

#### Case 2: Football is a dream, a dream to reality

Vinayjith C. V., 9 years of age, studying in the fifth standard in AUP School, Vadakkancherry, Palakkad, is a promising football player. Unfortunately, the child had neither the means nor the opportunity to nurture his skills and unlock his potential. The aspiring parents were quite concerned and were looking for sources to support them. Soon, they came to know about ESAF CYRC (Child and Youth Resource Centre) and managed to get him admission when the boy turned seven. His parents were quite determined to turn his dream of becoming a professional football player into reality.

From 2019 onwards, Vinayjith began to attend professional coaching sessions at CYRC. The training he underwent honed his skills and moulded him as a player. Later, he began to be recognised as the best forward in his team. The future looks bright for Vinayjith. During the All-Kerala Football Tournament (under 11) at Kuttanellur, he was the cynosure of all eyes, thanks to his stellar performance. He scored 15 goals and his team secured fourth place in the tournament in which many reputed clubs participated. He was the top scorer of his team and was selected as the emerging player of the tournament. Unsurprisingly, teams lined up to recruit him after the tournament.



# **Urban Initiatives**

### Thiruvananthapuram Organic Farming at Vattiyoorkkavu



ESAF partnered with Daya Kudumbashree to start organic vegetable cultivation at PTP Nagar, Thiruvananthapuram, as part of its International Women's Day Celebrations. The farming was initiated with the support of the HealthBridge Foundation, Canada and AstraZeneca's Young Health Programme (YHP). Adv. V. K. Prasanth, MLA, inaugurated the project in the presence of Smt. Sheeba, President, Kudumbashree ADS, Smt. Sanitha, Secretary, Kudumbashree ADS, and members of the Daya Kudumbashree.

## Kochi Beach Cleaning Drive at Fort Kochi

ESAF organised a beach cleaning drive at the Fort Kochi beach in association with Kochi Municipal Corporation, and the NSS Unit of Cochin College. In total, 140 students and volunteers participated in the beach cleaning drive.



# Kochi & Thrissur Promotion of Cycle Tourism

ESAF's efforts to promote cycle tourism, since 2017, are all set to come to fruition this year. The Government of Kerala gave Administrative Sanction (AS) to construct dedicated cycle tracks on the new State Highway that is planned alongside the state's coastline. ESAF will support the move by the committee of the Spice Route Muziris Heritage Project to promote Cycle Tourism along the beaches, from Ernakulam to Chavakkad. The Kerala Institute of Local Administration (KILA) has also included ESAF's Handbook in their training manual on how to create barrier-free public spaces, for the elected representatives of LSGIs and ULBs.

# AstraZeneca StepUp! Young Health Programme

ESAF partnered with the Kerala State Excise Department and Urban Local Bodies (ULBs) in all the districts to initiate Non-Communicable Disease Awareness Campaigns and campaigns against alcohol and drug addiction. ESAF identified vulnerable communities where drug peddling and alcohol addiction among young people were on the rise with the help of the Kerala State Excise Department. The Excise Department provided the list of red zones where such cases have been reported frequently. In total, 46 youth groups were formed in these areas during this period, and 1,475 young people, between the age group of 15 to 30 years, were enrolled in the project.

Several youth groups were trained with the help of specialized doctors from the Public Health Centres (PHC) to equip them to aid people suffering from alcoholism and drug

addiction which leads to NCDs. Public events and awareness campaigns such as cyclothons, walkathons, mini-marathons, football tournaments, wall paintings against drug addiction and alcohol, open street events and Beach for All campaigns for the differently-abled were organized across the district by the youth group members. These events helped to create awareness among youngsters and the general public about the importance of physical activities to prevent NCDs. Also, the youth groups were trained in organizing public events and campaigns with the support of the community and government departments.

The youth group members also introduced organic vegetable cultivation in coastal areas by mobilizing the support of the community and the Local Self Government Institutions (LSGI) to bring about behavioural change in young people. Drug peddling and alcohol addiction was a way of life for the youngsters in these areas. The LSGIs in Malappuram, Thiruvananthapuram, Kozhikode, Thrissur and Ernakulam districts gave 20,031.22 square meters of unused government land to the youth group members to launch the organic farming initiative. The initiative played a significant role in bringing a positive behavioural change among the youngsters and they began earning through the sale of vegetables. The project was helpful, to an extent, in dissuading youngsters, living in slums and coastal belts, from

consuming alcohol and drugs. The impact will be visible in the coming years. As of now, 2,840 Kg of different varieties of vegetables have been harvested by the youth group members from seven community farming sites.

In total, 1,475 young people directly benefitted from the project through 46 youth groups formed in the selected slum communities and coastal areas of 5 districts of Kerala.

### Outcomes

This project has built the capacity of 46 youth groups in Kerala to curb NCDs and take preventive measures against NCDs. Now, they have a better understanding of how alcohol and drug addiction can cause NCDs. They were at the forefront in organizing 14 anti-drug awareness campaigns in vulnerable communities with the support of the Kerala State Excise Department and Department of General Education, Govt. of Kerala. The campaigns helped significantly in sensitizing the college students, general public, media personnel, government officials, police department of fort to stop drug peddling in the red zones. The public events organized as part of this project had an indirect reach of 14,979 young people who were staying in the urban areas.

Out of 1,475 young people enrolled in 46 youth groups, 342 had the habit of taking alcohol or drugs at the time of joining. The activities and

campaigns initiated through the youth groups helped to bring a positive behavioural change among 123 young people out of the 342 who were addicted to alcohol and drugs earlier. They even stopped taking drugs and this change happened in the second half of the project period. We could provide the youth group members with a livelihood opportunity by involving them in community farming and the sale of organic vegetables.Earlier, they were into drug peddling to make easy money, but now this scenario has changed. They have started taking organic farming seriously, after getting a regular income out of it. Since the LSGIs extended their support through the community farming initiative, cases of drug peddling registered in the police stations in the coastal areas




have reduced drastically. The youth groups have entered into a partnership with the Kerala State Excise Department to organize anti-drug campaigns in all the slum communities and coastal areas across the state.

"I used to take cannabis regularly along with my friends. But, when I joined the youth group and started participating in the anti-drug campaigns organized as part of the project, I understood how badly it affects one's health. So, I decided to slowly quit using drugs. It was not easy, but, other members of the group helped me to overcome it. I am not taking drugs anymore and I am quite happy to be associated with this project." 21-year-old member Fort Kochi, Ernakulam

Urjabandhu is an entrepreneurship programme designed to train and establish entrepreneurs in the clean energy sector.

ESAF Urjabandhu Programme is a flagship programme for promoting and developing clean energy entrepreneurs with the support of ESAF Small Finance Bank. This initiative can gradually replace conventional energy with clean energy. ESAF has conducted 3 Urjabandhu Training Programmes in the year 2021-22 to train 57 candidates on PV System design, installation and maintenance. 16 candidates from Tamil Nadu and 41 candidates from Kerala benefitted from the programme.



The training was conducted at APS Poly Technic College, Kaggalipuru-Bengaluru, with the support of Kwatt Solutions Private Ltd. In Kerala, two training sessions were conducted at Mithradam Renewable Energy Institute, Aluva, with the technical support of MSME-TI, Thiruvalla. The duration of the training was 5 days and it covered both theoretical and practical aspects of the Solar PV System. The training covered a wide spectrum of topics, from basics such as electricity to advanced topics like the complete designing of different types of Solar PV Systems. The practical sessions incorporated into the training made the programme more effective. The entire training session was led by experts.

## Follow-up sessions for Urjabandhus



ESAF provided trained entrepreneurs with hand-holding support for progressing in their fields. Follow-up training sessions were conducted as part of the hand-holding programme. The Urjabandhu Team conducted 7 online follow-up meetings for clearing doubts and enhancing the knowledge of the entrepreneurs.

## Solar Dealers' Meet 🗸



As handholding support to the clean energy entrepreneurs, ESAF conducted solar dealers' meet for the Urjabandhus in Kerala and Tamil Nadu. The meetings were intended to strengthen the solar entrepreneurs and develop their business opportunities. Two meets for solar dealers were conducted in the year.



## Assembly training for Women 🔨

ESAF conducted a two-day training on LED circuits and LED starmaking to popularise and promote the use of energy-efficient products and encourage like-minded entrepreneurs. The twoday training held at MSME-Development Institute, Thrissur was organised with the technical and training support of the Department of Electronics, St. Thomas College, Thrissur.With the support of ESMACO,15 women from different locations in the Thrissur district participated in the training programme. The training helped the women to learn LED assembling and LED star-making.



## Marketing Support Marketing support for women entrepreneurs assembling LED lights

ESAF supported women entrepreneurs who received training on LED circuits and LED star-making for marketing their products during the Christmas season. The women trained under the programme expressed their interest in making and selling the LED stars in the market and ESAF took the initiative to support them in marketing their products. 6 out of 15 women who underwent the training came forward with a plan to produce and sell LED stars during Christmas. ESAF collaborated with ESAF SFB and Cedar Retail Private Ltd. to market the LED stars. As a result, CEDAR helped the women under the Mahilodaya Programme, and thereby 165 stars were sold through CEDAR, and 30 stars were sold locally. Through this, the women could earn a profit of Rs. 17,619/-.



## Marketing support for Urjabandhus

A marketing support meeting for the ESAF Urjabandhus in Kerala was organised at MSME DI-Thrissur on 28<sup>th</sup> February 2022. The agenda of the meeting was the formation and development of a cluster and the establishment of networks. A marketing support workshop was conducted for the 5<sup>th</sup> batch of trainees at MSME-DI, Thrissur, on 30<sup>th</sup> March 2022.

19 Urjabandhus attended the programme and received their certificates. The future plans of the Urjabandhus, marketing opportunities, and banking schemes were also discussed during the workshop. The office-bearers of ESAF SFB, ESAF Society, and MSME Department were present and spoke on the occasion.


#### Case 1: Urjabandhu Powers His Future

Urjabandhu has proved to be the right impetus for many aspiring entrepreneurs in the clean energy sector. The story of 43-year-old Muhammad Rahim from Thrissur is no different. For Muhammad Rahim, entrepreneurship was a long-cherished dream. Hailing from a middle-class family consisting of his wife and two children, he chased his dream with commitment. In 2019, just before the invasion of the pandemic wave in Kerala, he quit his job as a logistic professional abroad and relocated to his hometown to fulfil his dream. As his siblings were in the inverter and battery business, he didn't need to ponder too much about the path to be followed. He soon launched an inverter business but was quick to identify the potential of solar technology. Lack of expertise in the field held him back from exploring further. He, however, began to gather leads and relied on third parties for solar panel installations at a nominal commission. The growth opportunities of solar motivated him to make the big leap. With an aim to launch a solar installation business of his own he enrolled as a candidate in ESAF's Urjabandhu training programme. The five-day residential training on solar PV system design, installation, and maintenance, from 21st to 25th April 2021, at Renewable Energy Institute, Mithradham, Aluva,

opened a new world of possibilities to Muhammad Rahim. He not only learned about the technical aspect of the solar PV system but also gained insight into the marketing aspect of the technology. The training helped him to elevate his business to a new level. He completed seven solar projects (on-grid and off-grid) of 31 KW capacity as of January 2022 and earned a profit of around Rs. 3,10,000. ESAF's training brightened the business prospects of Muhammed Rahim's enterprise; he is looking forward to creating employment opportunities for unemployed youth in his neighbourhood through his venture. "I am forever indebted to ESAF for the Urjabandhu training. It not only opened the doors of solar business for me but also taught me to manage a business successfully," he did not hide his happiness and gratitude while concluding.

Enhancing employability and entrepreneurship through training and mentorship is one of the most significant aspects of the skill development programme. Through the initiative of the Skill Development Team, ESAF could train 1,944 women SHG members by way of online webinars, apart from 51 skill development training sessions conducted on topics like food

processing, tailoring, beauty & wellness, agriculture-related activities, EDP & marketing. Even amidst Covid - 19 restrictions and social distancing, ESAF organised skill development training in Kerala, Tamil Nadu, and Karnataka with the support of ESAF Small Finance Bank. The support from ESMACO ensured the smooth execution of the programme.

## 



In the food processing sector, ESAF conducted 16 training sessions on different topics such as chocolate & cookie making, cake making, pickle making, malt making and

creating value-added products from mushrooms. Through the training, ESAF reached 556 women entrepreneurs from Kerala, Tamil Nadu, and Karnataka.

## Tailoring 🔨



Tailoring is a sector in which women entrepreneurs have a huge scope for success. Therefore, ESAF conducted 16 advanced training sessions in tailoring and trained 484 women. The topics covered through the training were,

kidswear and jumpsuits, floormat making, cutting, designing and stitching, making masks & cloth carry bags, and stitching curtains.

## Beauty & Wellness



Beauty and Wellness training sessions were provided to the existing women entrepreneurs working in the beauty and wellness sector. 41 women entrepreneurs were trained in beauty and wellness through 2 training programmes.

## EDP and Marketing 🔨

EDP and marketing training was conducted for entrepreneurs and small and marginal employees as part of the skill development training. Apart from this, 8 training programmes were carried out and 276 women were trained in marketing and entrepreneurship.



## Agriculture Allied Activities 🔨

Agriculture and Allied training sessions were organized for the women who were working in the agriculture sector. 145 women were trained through 3 training sessions.





## Online Webinar 🔨

Online webinars were conducted for women entrepreneurs to clear doubts and enhance their concept clarity. Trade-wise sessions, as well as sector-wise sessions, are organized as a part of the training. 6 online webinars were organised and ensured the participation of 442 women in the sessions.

#### Case 1: The training that makes her life beautiful

Sajeera T. K., 36 years, runs a beauty and wellness clinic. Her family hails from Ammanappara, Kannur. Her family is made up of her husband and two children. Her children are pursuing their education and her husband is a gulf returnee.

A few years back she learned a beautician course from a private institute and joined a beauty parlour in Taliparamba. She had plans to open a shop of her own after learning the ropes of the trade. Once she gained sufficient experience, she started a parlour as planned, in Pazhayangadi. Her beauty parlour was registered under District Industrial Centre, and she was earning around Rs. 25,000 per month as profit. But the happiness did not last long, the 2020 lockdown shook her business to the core and she was forced to shut the shop. Her husband also lost his job around the same time.

Sajeera did not lose hope amidst the crisis. She brought all the beauty equipment home and began operating from her house. Customers visited her house whenever they needed her services, she also offered doorstep services to her clients.

It was at this juncture that Sajeera heard about the beauty and wellness training and Entrepreneurship Development Training organised by ESAF at Kannur. She joined for the same and successfully completed it. This helped her in two ways. Through the training, she learned the latest techniques in beauty & wellness and also gained the confidence to restart her beauty parlour. She opened a beauty parlour cum tailoring centre at Talipparamba, near her home.

She is a part of ESAF Sangam since 2018 and is thankful for ESAF's timely support in developing her business. "ESAF's training rejuvenated my skills and gave me the confidence to restart the parlour. Now I am planning to upscale my business," she concluded gratefully.





#### Case 2: She realises her dreams through designing

Ajitha T. belongs to a middle-class family comprised of her husband and two children, a boy and a girl. Her husband works as manual labourer in the gulf and Ajitha is in charge of household chores.

Ajitha was born and brought up in Coimbatore, Tamil Nadu. Once she completed her matriculation, she set out to learn new skills as she was not keen on pursuing higher studies. She opted for sewing and began to work in a garment company nearby.

After marriage, she shifted to Palakkad and her husband's meagre earnings were the only source of income for the family. The financial requirements of the family piled up after each passing day. The education expenses of the children further worsened their financial condition.

Soon, her husband migrated to the middle east in search of better employment opportunities. Ajitha then used her tailoring skills to support her husband. In 2018, with ESAF's support, she purchased sewing machines and established a tailoring centre.

She used to take orders for school uniforms, kidswear & ladieswear. During peak seasons such as Onam, Ramadan & temple festivals and the beginning of the academic year, she even hired a part-timer who could also sew menswear.

Generally, she used to earn around Rs. 10,000 per month, but the Covid-19 pandemic affected her enterprise and this was reflected in her monthly income.

She was looking for a way to further expand her business but she was badly in need of learning new skills other than stitching. It was during this time that the ESAF Sangam informed her about the skill development programmes of ESAF. She then attended the training for Saree designing and the Entrepreneurship Development Programme.





The training programme helped her in two ways. Apart from fabric painting, she learned how to successfully run an enterprise. The new skills that she learned are helping her in designing new patterns and she is getting new orders for designs. As a result, there has been a significant improvement in her monthly income. Ajitha is very optimistic about expanding her enterprise further. She expressed her gratitude towards ESAF for organising such training sessions.

## Skill Training for Youth $\nabla$ DDU GKY (Deen Dayal Upadhyaya Grameen Kaushalya Yojana)

The Government of India has set an ambitious target for providing skill training to 500 million of its youth by 2026, which is in line with the estimated demand for skilled manpower over the next decade. As per the 2011 Census, India has 55 million potential workers between the ages of 15 and 35 years in rural areas. At the same time, many industrialized nations are facing the problem of an ageing population. Some of these countries are expected to face a cumulative shortage of 57 million workers by 2025. These numbers represent a historic opportunity for India to transform its demographic surplus into a demographic dividend.

(NRLM), tasked with the dual objectives of adding diversity to the incomes of rural poor families and catering to the career aspirations of rural youth. DDU-GKY is uniquely focused on rural youth from poor families, between the ages of 18 to 35 years. As a part of the Skill India Campaign, it plays an instrumental role in supporting the social and economic programmes of the government. ESAF has been partnering with NRLM by training and placing 1,195 rural youth under the DDUGKY Programme as a Programme Implementing Agency (PIA). Today, ESAF Academy for Professional Skills shines as a youth development centre in Kerala, a hub for the development of youth from marginalized and deprived communities.

#### **Diagnostic Study- Kuthampully Weaving Community**

Following the successful campaign of KaitharikkoruKaithangu, a diagnostic study has been planned with the support of NABARD The diagnostic study revealed the following needs of the weaving communities:

▶ **Marketing intervention** – A professional marketing system needs to be envisioned and implemented with consistency to bring a change

**Financial intervention** – Crowdfunding, working capital, loans, etc. are necessary to fund their current debt and to keep a reserve fund for the future interventions of the project

**Design intervention** – Professional design support is required to repurpose the traditional weaving skills, to address the contemporary market and the target segment

**Workforce intervention** – Need capacity building and skilling of the key stakeholders in the project- the weavers

# / LIMS SKILL TRAINING: / Equipping youth and women for employment through skill training

LIMS, a skill training Institute of ESAF, aims to enhance the employability of marginalised youth and women from the hinterlands of Jharkhand through skill training programmes. LIMS collaborates with NGOs and Government Organizations to identify and train beneficiaries. The Chief Minister's Micro Enterprises Development Board, Jharkhand, NABARD and Sido Kanhu Murmu University (SKMU) Dumka, Jharkhand, are some of the agencies that are associated with LIMS.

## SKMU Certified Skill Training Programme 🗸

LIMS launched several skill training certificate courses in association with the Sido Kanhu Murmu University. Natural Fibre Arts & Craft, Tribal Arts & Craft, Textile & Apparel Value Addition, Agriculture & Medicinal Plants, and Micro Enterprises Development were some of the courses that were launched as part of the initiative. 1,179 members benefitted from the six-month certificate courses. The participants were from different districts of Jharkhand, Orissa and Bihar.



A handicraft skill training programme was organised with the support of Mukhyamantri Laghu Evam Kutir Udyam Vikas Board, and the Government of Jharkhand. 200 beneficiaries from the Schedule Caste communities of Godda, Pakur, Sahabganj, Jamtara, Deogarh, Dhanbad, Giridhi, East Singhbhum, and Seraikela & Kharsawan districts of Jharkhand participated in the programme.



As part of NABARD's Skill Development Programme, 60 women were trained in bamboo and cane craft making. The trained

women were linked to the regular supply chain of production through ESAF Swasraya Producer Company Limited.

## Case Study

#### Case 1: Merila can dream now!

Merila Marandi, from Majdiha village in Dumka, lost her mother when she was 10 years old. She had to shoulder the responsibilities of her home and take care of her three younger siblings. Merila's father was engaged in subsistence farming, gathering just enough for the family to have food three times a day. It was difficult for the father to engage in any other work, leaving behind the three young girls alone at times.

The turning point came for the family after Merila joined a skill

development programme at LIMS. After being trained, Merila also trained her sister in making bamboo-based products. Now, the sisters are able to earn about Rs. 13,000 a month. This income has helped the family to have a better quality of life. More importantly, it has helped Merila's younger siblings to have access to better school and tuition facilities, and even wear decent clothes - things that were beyond their reach earlier. Merila and her sister are continuing to work hard to save money so that they can resume their studies. She is on her path to fulfilling her dreams!

## / Development Support Programme for Stone Quarry affected Communities (DSSQC)

The development support for communities affected by stone quarries at Shikari Pada block of Dumka, Jharkhand and Birbhum districts of West Bengal focuses on providing alternative livelihood and education support for the community members. It includes non-agri based livelihood training programmes, entrepreneurship development, marketing support, bridge school, moral education and an awareness programme on financial services.

## Livelihood Programme 🗸

- 1. Stitching
- 2. Water hyacinth-based craft training
- 3. Furniture-making training
- 4. Stonecraft training
- 5. Bamboo plantation training
- 6. Palm leaf-based product-making training



**Marketing Support** - ESAF provided marketing support to community members trained in different types of livelihood income generation programmes through various modes.



1. Common Facility Centre (CFC) – Beneficiaries trained in craft-based products were linked through the CFC which is set up at Telbula village in Dumka. ESAF supported the marketing of craft products made by beneficiaries through the CFC.

2. Farmer Producer Organisation (FPO) – ESAF provided marketing support to bamboo farmers at the Shikaripada area. Realising the scope of bamboo for various commercial purposes, many farmers opted for training in bamboo cultivation. ESAF is providing the marketing support to the farmers by linking them to bulk buyers.



3. Women trained in making apparel received orders for stitching eco-friendly bags.

4. Products were promoted through FabIndia and e-commerce. Market orders on craft products were mobilized through ESAF Swasraya Producer Company Ltd.

**Entrepreneurship Training Programme** - ESAF conducted Entrepreneurship training programmes for 42 community members to mould their skills in bamboo-based entrepreneurship.

Setting up and Development of Training Centre - ESAF set up and developed a training centre for teachers training, carpentry, handloom, stone craft, tailoring and bamboo cultivation at Benagaria, Shikaripara.





#### **Education: Bridge School**



Bridge School was a place of hope for rural children during the lockdown period. As all schools were closed for almost two years, bridge education supported 575 children with daily tuition services. In rural villages, children were taught through stories, rhymes and activities with the support of audio-visual materials.

#### **Kids Club**

In the monthly Kids Club Programme, children were taught moral values through stories. Kids Club Programmes were conducted in 25 villages and 641 children participated in the same.

Hopna Soren from Aamchua village in Dumka was unable to attend school for two years due to the COVID-19 lockdown. It was during this time that the Bridge school began providing daily tuition for one and a half hours. Hopna attended the tuition regularly and continued learning through audiovisual classes.



## **Promotion of Bamboo MSME Cluster for Sustainable Development - An EU - SWITCH ASIA Project**

The objective of the EU-Switch Asia Project is to promote bamboo as a sustainable resource and generate green jobs. The project is designed to help the local community and other stakeholders to collaborate for the promotion of a green economy, sustainable growth, economic prosperity and poverty reduction along with mitigation of climate change.

#### Case 1

Sunita Mohali from Lakhikundi village, Dumka, is a bamboo artisan. Like most artisans, she was struggling due to the lack of systematic marketing channels. Due to her meagre earnings and lack of sufficient marketing support, she was not in a position to increase production. After attending the skill enhancement training, Sunita started getting work orders from ESAF Swasraya Producer Company Limited to produce lifestyle handicraft products. Financial linkages helped her in buying raw materials for bulk orders. ESAF's intervention helped many artisans like Sunita to get financial support and take up bulk orders. Sunita was also able to construct a house with the additional income she earned.

## **Farm Sector**

ESAF aims at overall livelihood improvement of farmers by providing on-field support through trained entrepreneurs (Pashumitras and Krushakmitras), strengthening Farmer Producer Organisations through training and market linkage and thus creating sustainable livelihood for farmers.

#### **Pashumitra Training**

Pashumitra is a flagship project of ESAF where, Pashumitras are Dairy Entrepreneurs who are trained to provide dairy based services to the farmers of FPOs. With the support of ESAF Small Finance Bank, Pashumitra training was conducted at BAIF, Karnataka, for creating socio-agriculture entrepreneurs in rural areas to support dairy farmers. Under the programme, ESAF mobilized and trained 25 candidates from Karnataka (7) and Tamil Nadu (18). The training focus was on practising artificial insemination in fields. The in-house and field training helped the trainees to effectively support the dairy farmers in artificial insemination and in supplying nutritional feeds for the cattle.

#### Follow-ups/Refresher Training

For improving the theoretical and practical knowledge of the existing Pashumitras, ESAF conducted refresher training and orientation programmes. Three refresher and follow-up training programmes were organised in the year 2021-22 to support the entrepreneurs in upgrading their knowledge as well as clearing their practical doubts during the field-level interventions.

- 25 candidates have successfully completed Pashumithra training

#### Krushakmitra Training

Krushakmitras is a flagship project of ESAF where, Krushakmitras are Agri Entrepreneurs, who are trained to provide agriculture based serviced to farmers of FPOs. With the support of ESAF Small Finance Bank, Twenty-seven entrepreneurs from Tamil Nadu were trained under the Krushakmitra Programme as part of the CSR initiatives of ESAF Small Finance Bank. The training was organized for two batches, with the participation of 27 candidates, in the training institutes of MYRADA training centre, Hosur, and KVK, Krishnagiri. The technical support for the training was provided by KVK, Krishnagiri. After the completion of the training, the Krushakmitras were equipped with tool kits and uniforms for extending their support to the farmers in the villages.

#### **Refresher Training**

ESAF conducted a follow-up training for the existing Krushakmitras at KVK, Krishnagiri, to enhance their theoretical and practical knowledge. The important areas covered through the training were agent banking, business plan preparation, linkages with Cedar Retail Pvt Ltd., and the roles and responsibilities.

## Results (Outcomes and Impacts) abla

> 27 Candidates have successfully completed the Krushakmitra training

Microbial consortium (INM)-8000 kits, Pseudomonas IPM 8000 kits and Trichoderma IDM 9000 kits worth Rs. 5.7 lakh have been procured from ESMACO and were distributed to 25000 farmers for demonstration purpose









#### Setting up of Milk Collection Centres

With the intention of supporting the dairy farmers in rural areas, ESAF set up milk collection centres to procure milk and to ensure fair pricing to the farmers. As part of its CSR initiatives, ESAF SFB established 10 milk collection centres with ancillary equipment. As of now 14 milk collection centres are functioning, procuring 3,500 litres of milk per day on average.

The farmers are getting an additional benefit of 1 rupee per litre of milk from the established collection centres and the milk collection agents are also getting the benefit of one rupee per litre. Hence the collection centres are helping the farmers to get fair pricing on one side while providing a source of livelihood for the milk collection agents on the other side.

## Results (Outcomes and Impacts) abla

- > 13 dairy collection centres are functioning and procuring 11,47,195 litres of milk per year, worth Rs. 39 lakh
- > Through the milk collection, 13 entrepreneurs have received a total of Rs. 11.5lakh as incentive in the year
- > 23 dairy farmers availed of Dairy loans worth Rs. 36.8 lakh from ESAF SFB





As part of extending support to the farmers at the grassroots, ESAF initiated capacity-building and market linkage support programmes through the support of ESAF Small Finance Bank CSR projects in the farm sector. In the year 2021-22, four buyer-seller meetings and one training on branding, packaging, and licensing were organised.

#### **Buyer-Seller Meetings**

For the promotion of Farmer Producer Organisations and their products, ESAF organized 4 buyer-seller meetings in Tamil Nadu in the year 2021-22. Prospective buyers, representatives from the Government Agriculture Department, NABARD, ICRISAT, and farmers attended the meetings. The buyer-seller meetings were organised at Ariyalur, Permbalur, Nilgiri, and Hosur. Altogether 56 FPOs were present in the buyer-seller meetings.



#### Training on Branding, Packaging, and Licensing

A training session on branding, packaging, and licensing was carried out at MABAIF, Madurai. 22 farmer representatives from 8 FPOs attended the training.

▶ 13 FPOs have been involved in collective, marketing benefitting 2013 farmers

> 2094 tonnes of Agri produce (vegetables, millets, and flowers) worth Rs. 589.56 lakh have been marketed during this financial year

ESAF has been empanelled by NABARD and NCDC to promote 40 Farmer Producer Companies in 8 states

## Training & Exposure Visits 🗸

A two-day capacity-building training was organized in Kerala for CEOs of Farmer Producer Organisations and their supervisor cadre employees viz. cluster coordinators. The training covered sessions on Roles and Responsibilities of CEOs, Conflict Management, Project Management, Financial Management, Record Maintenance and Regulatory Compliance. Apart from this, CEOs of successful FPCs shared their experiences during the programme. Several exposure visits, to successful FPOs and nearby KVKs, and sessions for overall improvement of FPO activities were conducted for the FPO members. 50 FPO members from ED Oil Palm FPCL, Telangana, visited the Ashaaropet plantation in Khaamam district to learn more about oil palm cultivation. 10 BoDs of Nila FPCL, Kerala, visited Valluvanada FPCL, Malappuram, to understand the basic strategies behind procuring and marketing coconuts.



## Results (Outcomes and Impacts) 🗸

21 FPCs from 5 states received sanctions worth Rs. 18 lakh each for FPC management. FPC Offices were opened in all the states and they were inaugurated by officials from NABARD, ESAF and Government Departments.

▶ An equity grant worth Rs. 6,00,000.00 was received by Nila FPCL, Kerala and another grant worth Rs. 82,600.00 was received by Jai Kishan FPCL, Odisha, from the Central Government as part of its efforts to empower progressive FPOs for furthering their business.

▶ A piece of land was allotted to Bheemadevarapalli FPO in Telangana, by the State Government, for setting up an office of their own.

▶ First General body meeting were held in 4 blocks in Kerala, 2 FPCs in Telangana, 3 FPCs in Chhattisgarh, 2 FPCs in Odisha, 2 FPCs in Maharashtra, and 2 FPCs in Telangana, involving hundreds of farmers. Officials from NABARD, the Agriculture Department and the Horticulture Department, and several MPs and MLAs participated in the meeting. Share certificates were issued to farmers during the meeting.

▶ Setting up of a Coconut Dehusking Machine with a capacity of 4,000 nuts/day and an Arecanut Dehusking Machine with a

capacity of 300 kg nut/day in FarmAsist FPCL in Irrity block in Kerala, gave cost advantage to FPO members as well as other farmers in the area.

▶ The partnership between Nila FPCL and Keramithra, ensured FPO members received regular services with a 50% discount on coconut harvesting, addressing the labour shortage and high cost of harvesting coconuts.

▶ Sonadehi FPCL in Chhattisgarh assisted farmers to get paddy sacks for Rs. 30.00 per sack instead of the market price of Rs. 45.00. So far, 3,500 paddy sacks have been distributed.

▶ A farm school programme was launched at Greens Mala FPCL, Kerala, with the support of the State Biodiversity Board. Farmers were trained in various agriculture programmes including soil conservation.

▶ Installation of mustard oil extraction unit and the launch of mustard oil brand "Desi" in BMK FPC in Chhattisgarh, increased the income of FPO farmers through value addition of produces.

▶ Share capital of Rs. 87 lakh wascollected by 40 FPOs comprising 6,636 members



## Small Farmers Agri Business Consortium Projects 🔨

Formation and capacity building of 6 FPOs have been completed in collaboration with Small Farmers Agri Business Consortium, Tamil Nadu. Input shops were established by 2 FPOS while the business plans are being prepared by all the FPOs.

Evangelical Social Action Forum (ESAF) in partnership with Godrej Agrovet Pvt. Ltd. has been implementing the 'Integrated Rural Livelihood Project' (IRLP) in three villages Seethanagaram, Meddisettivaripalem (M V Palem) and Chintampally, falling under Chintalapudi Block in the West Godavari District of Andhra Pradesh. The main objective of the project is to create livelihood options for communities in the three villages, which comprise 1510 households. Andhra Pradesh. The Mandal Headquarters is in Chintalapudi town. Nuzvid City, Eluru City, Hanuman Junction City and Kothagudem City are the nearby cities.

Chintalapudi consists of 72 villages and 20 panchayats. Gopalapuram is the smallest village and Chintalapudi is the biggest village. It is at 21 m elevation (altitude).

Bhadrachalam, PapiKondalu (Papi Hills), Vijayawada (Bezawada), Rajahamundry, and Amaravathi are nearby important tourist destinations.

Chintalapudi is a Mandal in the West Godavari District of

## Project Activities Enabling Entitlements

#### Formation of Farmer Producer Collectives

Farmers Interest Groups were formed for the purpose of creating Farmer Producer Companies. As part of the process, communities were mobilised and were made aware of collectivisation and its advantages in input purchase and output marketing. This was followed by the formation of 10 Farmers Interest Groups comprising 160 farmers from 3 villages. Various training sessions were conducted for the members with a focus on the roles and responsibilities of FPC members and the Govt. schemes available for FPCs.

Efforts were made to link members from Farmers Collectives to NABARD Programmes. NABARD invited members from Farmers Collectives to take part in Women's Day Celebrations. Women representatives from Farmers Collectives took part in the celebrations. This is an example of the visibility of the organisation's interventions among other agencies.

#### **Development Seminars**

Development seminars were conducted with community members to increase their awareness on Government Schemes and entitlements. Six such seminars were conducted and the members learnt about financial literacy and various Government schemes through the programme. Some of the schemes that had been availed of by the members were PM Jeevan Jyothi Bheema, PM Suraksha Bheema Yojana, SC Corporation Loan Scheme, YSR Pension Scheme and YSR Bheema Scheme.

More than 50 members have applied for various Government Schemes and 30 members have availed of the benefits.

## Dairy and Poultry Development

#### **Veterinary Camps**

As part of organising Veterinary Camps, several training sessions, led by experienced veterinary doctors, were conducted to increase the awareness and knowledge of the members on animal management.

Three veterinary camps were organized for the prevention

of diseases among milch animals, sheep, goats and poultry. 145 members benefitted from the camps and received free medicines for preventive and curative purposes. 2,503 animals were examined in the camps.



#### **Backyard Poultry Enterprise**

58

Backyard poultry was encouraged among beneficiaries to create an alternate livelihood option. 20 one-month-old chicks of the Rajashree variety, along with 2 cages to protect the birds, were provided to women beneficiaries to create a women-led poultry enterprise. 100 women benefitted from the programme.

Beneficiaries were provided with field-level training that focused on the benefits of poultry farming and the management of chicks (feed, medicine, regular care).



## Agriculture Development 🗸

#### Agriculture Training

Agriculture training was provided to encourage environmentally friendly agriculture practices among community members. Various training sessions were organized by Krushi Vigyan Kendra, VR Gudem and Andhra Pradesh Agriculture Department to train members on seed treatment (bio-fertilizer), Integrated Pest Management (IPM), Integrated Disease Management (INM), Integrated Nutrient Management and Post-Harvest Management. The training also focused on Input Management and touched upon practices for better productivity and land preparation.

## Establishment of Intercropping Demo Plots 🗸

A demonstration was conducted on intercropping of fodder in oil palm farms and coconut farms. Farmers were provided with improved fodder seeds to create additional income by selling green fodder on unutilized agricultural land.





## Promotion of Kitchen Garden 🗸

Kitchen gardens were promoted in the community to create a self-sustainable model for procuring organic vegetables. Seeds given to the members were open-pollinated so that they could be used for the next generation. More than 1,000 households were a part of the programme and they began to grow vegetables in their backyards.



## Water and Sanitation Promotion of Pipe Composting 🔨

Pipe composting is an alternate method of composting kitchen waste, which could be used in kitchen gardens to increase productivity and reduce environmental pollution.

## Demonstration of Soak Pits 🔨



A soak pit is a simple and cheap drainage structure facilitating the disposal, filtration and percolation of wastewater into the ground. During the project period, 15 soak pits were constructed to demonstrate the safe disposal of wastewater in three villages. These soak pits were constructed near washing areas and locations without proper drainage systems.

## Setting up of RO Plants 🔨

Two RO plants have been installed, one each in M. V. Palem and Seethanagaram, with capacities of 1,000 ltr and 2,000 ltr respectively, depending on the population of the villages.

In M. V. Palem and Seethanagaram, the installation has been completed and the plant has begun functioning.

## Promotion of Women Water Enterprise Group



Two women members were trained to maintain and operate the RO plants to create a selfsustainable model in the village. Apart from managing the unit, women entrepreneurs are able to earn an income through the initiative, by charging for their services.

## **Covid-19 Interventions**

To ensure the health and hygiene of people in villages, hand sanitisers and masks were distributed among them during the pandemic. Small group meetings were conducted in villages to spread awareness on hygienic practices and slogans were painted on walls to popularise health and hygiene.

## Common Facility Centre 🗸

A common facility centre was established in the project location to provide alternate livelihood training to community members. 20 women were trained in tailoring and 6 of the trained women sew masks and provided them to people at the Velugu (Institution for SHGs) and Chintampally Gram Panchayats.





20 children from classes 8 and 9 enrolled in computer classes at the centre. 71 children from a government school were also provided with computer classes weekly twice. The classes equipped the children with basic knowledge on computers.

## Changing lives in a Sustainable Manner

Moligimuti Rebhamma hails from Chintalapudi Mandal of West Godavari District. Her family comprises her husband, son and daughter. Daily wage labour and agriculture were the main sources of livelihood for the family. Her family used to purchase vegetables from nearby markets for Rs. 1,200 per month. The cost used to go up seasonally as the price of vegetables often shot up. Moreover, the vegetables, grown using chemical pesticides and fertilisers were of very poor quality.

#### **GAVL-IRLP Support:**

She was an active participant in all the awareness programmes that ESAF conducted in her village and attended training on the importance of kitchen gardens and the PVC pipe method for compost generation using kitchen waste. After the training, she was eager to execute these activities at her house and approached ESAF for support. Through GAVL- IRLP Project's support, she received a vegetable seed kit (consisting of 12 types of seeds) in December 2020. She sowed all the seeds as per ESAF staff's guidance. After 20 days, she could harvest leafy vegetables from her garden & after 30 days she could collect other types of vegetables from her kitchen garden. Now, her family consumes fresh vegetables produced daily in her kitchen garden and shares the extra quantity produced with her neighbours. Her family slowly reduced its dependency on vegetables from the external market and moved towards self-reliance. As a result, she could improve the health of her family members and save Rs.1,200 monthly.

Through the IRLP project, ESAF also supported her with a PVC pipe compost unit for efficient management of household waste during January 2021. She established the unit in the

kitchen garden near her house. The family filled the pipe with kitchen waste and dry leaves in a systematic manner and maintained the required moisture level by adding water/dung slurry. After the pipe was filled, they left the unit for 45 days to complete the composting process. After 45 days, dark browncoloured compost (8 kg) was generated from the unit and it was used in the kitchen garden as manure.

## Changing lives in a Sustainable Manner

Adapa Mallikarjuna Rao's family consists of two members, his mother and himself. They live in Seethanagaram village, Chintalapudi Mandal, West Godavari District, Andhra Pradesh. His family's main source of livelihood was a Kirana store. They used to purchase vegetables from the nearby market for around Rs. 800 per month and they were often not fresh, as they were grown using chemical pesticides and fertilisers.

#### **GAVL-IRLP Support:**

He attended awareness classes on the importance of Kitchen Gardens and PVC pipe method compost generation using kitchen waste. Soon, he was keen to implement these activities at his house and approached ESAF for support. In December 2020, through the GAVL- IRLP project, he received a vegetable seed kit, consisting of 12 types of seeds. He sowed all the seeds as per ESAF staff's guidance. After 20 days, he could harvest leafy vegetables & after 30 days he could harvest other types of vegetables from his kitchen garden. Now, his family consumes fresh vegetables daily, from the kitchen garden and the extra quantity of vegetables produced is sold to others. Also, they are not dependent on the external

market for daily vegetable consumption.

Through the IRLP project, during January 2021, ESAF also supported his PVC pipe compost unit, for efficient management of household waste. He established the unit in a kitchen garden near his house. The family filled the kitchen waste & dry leaves waste systematically in the pipe compost unit and maintained the required moisture by adding water/ dung slurry. After filling, they left the pipe compost unit alone for 45 days, to complete the process. After 45 days, dark brown-coloured compost (12 kg) was generated from the unit and it was used in the kitchen garden as manure.

## Sustainable Dairy Farming through Improved Variety of Green Fodder

U. Bhaskar Rao's family consists of three members, his wife, a grandchild and himself. He lives in M. V. Palem Village, Chintalapudi Mandal, West Godavari District, Andhra Pradesh. Buffalo rearing was the main source of income for the family. They had 4 buffaloes & 2 sheep and they used to purchase the fodder & feed from the outside market. Previously they used to purchase dry fodder worth approximately Rs.15,000 every year and they used to incur an expense of Rs. 1,000 for animal health. As the quality of common fodder and pasture resources often got degraded drastically, over a period of time, milk production was reduced and it affected the income of the whole family.

#### **GAVL-IRLP Support:**

He came to know about ESAF and its initiatives by attending a veterinary camp at MedisettivariPalem village and soon approached ESAF to try the green fodder seed variety on his land. In March 2021, he received 5 Kg of Sorghum Sudan grass (SSG) seeds, a drought-resistant and high-yield variety, with the support of the GAVL-IRLP project and sowed them in 20 cents of land on his coconut farm. He was able to get 150 Kg of green fodder in a single harvesting stage, which was sufficient for rearing 4 animals. As he was able to get yield every 15-

20 days, he could always ensure the availability of fodder. He was very impressed with the Sorghum Sudan Grass as he was able to overcome the green fodder deficiency using it.

The milk production per buffalo increased by 1 litre (morning and evening) per day. Overall milk production increased by 4 litres per day and the fat content increased by 2%. Now, he is able to get Rs.150 more per day from milk production. Green fodder has not only increased his income but has also





improved the health of his animals. His family was able to reduce the purchase of dry grass fodder, up to 50 %, compared

to the previous quantity and he could save Rs. 7,500 yearly.

## Producing Compost with Household Waste 🔨

Vallepu Ramadevi's family consists of 4 members, her husband, two sons and herself. They live in Seethanagaram Village, Chintalapudi Mandal, West Godavari District, Andhra Pradesh. The family members' main occupation was Agriculture and Agriculture allied activities. The family was facing the issue of waste composting and was forced to throw the household waste near the house, at a compost pit.

#### **GAVL-IRLP Support:**

She was an active participant in all the awareness programmes that ESAF conducted in her village and attended training on the importance of kitchen gardens and the PVC pipe method for compost generation using kitchen waste. Soon she showed interest in implementing these activities at her house and approached ESAF for support. In January 2021, through the IRLP project, ESAF supported her PVC pipe compost unit for the efficient management of household waste. She established the unit under a coconut tree near the house. Her family filled the kitchen waste & dry leaves waste in the pipe compost unit systematically and maintained the required moisture by adding water/dung slurry. After filling, they left the pipe compost unit alone for 45 days to complete the process. After 45 days, dark, brown-coloured compost (10 kg) was generated from the unit and it was used in the kitchen garden as manure.

In Vallepu Ramadevi's words-"We used to throw household wastes into a common pit. After learning about the PVC pipe method, we were able to generate compost while maintaining hygiene around the house. I am grateful to ESAF and GAVL for the training they provided to us."

## Mental Health Awareness 🗸

According to WHO, 'health is a state of complete physical, mental, and social wellbeing and not merely the absence of disease or infirmity.' ESAF focuses on ensuring the mental health of the general public by spreading awareness on mental health. A series of mental health awareness sessions were carried out through online and offline modes across the state of Kerala. The topics covered through the sessions included strengthening family bonds, finding and sustaining happiness in daily life, managing stress, and the importance of mental health in daily life. Through the awareness sessions, ESAF reached out to 1,258 individuals.



#### Barefoot Counsellor Training



To ensure the mental health of the rural masses, ESAF introduced the concept of training and developing barefoot counsellors (Manomithras) at the village level to provide befriending services to the needy. As a result of this initiative, ESAF trained 56 women as barefoot counsellors including ASHA workers, MSW graduates, health nurses, and Sangam members. The topics discussed during the sessions were mental health basics-risks and protective factors, signs of mental illnesses, types of mental illnesses, treatment options, sample case identification and discussion, suicide prevention, parenting & dealing with adolescent issues, and self-awareness & relaxation exercises, and analysis of case studies.

#### Follow-up Sessions for Manomitras



ESAF conducted periodic follow-up sessions through online and offline modes to update the theoretical and practical knowledge of the Manomitras (barefoot counsellors). Some of the topics discussed during the follow-up sessions were cognitive behaviour therapies, substance abuse treatment, the role of community volunteers, major symptoms of delusional disorders, and grief counselling. Discussions and case studies were used to ensure effective communication during the sessions.

#### **Tele-Counselling**

People struggling due to pent-up emotions and family problems were provided with befriending services via a helpline. Counselling services were provided by professionally qualified social workers/counsellors of the Santhwana team. 289 tele - counselling sessions were conducted in the year 2021-22. Marital problems, depression, psychiatric symptoms, scholastic problems, autism, behavioural problems, alcoholic addiction, post-partum depression, and interpersonal issues were the common problems addressed through telecounselling services. The services were provided to them in the form of active listening, psycho-education, referral to the concerned DMHPs, cognitive reframing, and emotional support.

#### Mental Health Assessment of Bedridden Persons

A mental health assessment of bedridden persons was conducted as part of the Santhwana Project. The intention behind the assessment was to analyse the mental health of individuals bedridden due to various health issues. Bedridden family members from Sangams were identified with the

help of ESMACO and the social workers of the Santhwana team visited their homes to understand their condition. The assessment was done on 30 bedridden individuals with the help of a structured questionnaire.

## Family Care Plan 🔨

ESAF supported 4 families under the family care plan of the ESAF Santhwana Project. The families were selected after a thorough analysis of their financial and medical situations (at least one of the family members should be bedridden or suffering from severe health issues and should belong to the below poverty line category), and the families were provided with financial support to meet their medical and hospital transportation expenses, and caretakers of the bedridden were provided with vocational training.







## Vocational Training for Differently-abled Children 🔨

The economic independence of differently-abled children is one of the major concerns of their parents. Drudgery-free and feasible income generation models are ideal for ensuring the economic independence of children with disabilities.

It was found that activities like LED bulb assembling, paper bag making, and Nettippattam making were suitable for the children to learn quickly and earn a living with ease. The parents of the children accompanied them to the training sessions and learnt the skills. 98 children with disabilities, along with their parents, participated in three vocational training sessions. The training not only helped the children to acquire a new skill that would ensure their economic independence but also helped them to come out and interact with each other.



## Special Programmes for Elderly

A pleasure trip was conducted as part of the special programmes organised for the elderly under the Santhwana Project. Also, a need assessment was conducted among the elderly in the Nadathara Gram Panchayat with the support of the Kudumbashree Mission. A significant majority of the participants opined that the pleasure trip gave them an opportunity to interact with nature and improve camaraderie among them. In the pleasure trip to Peechi Dam, representatives from Kudumbashree CDS and Gram Panchayat also participated. 26 elderly persons participated in the programme and as part of the trip, the project team organized group activities, games, and yoga sessions. The programme helped the participants to become relaxed and encouraged them to remain active in the group with games and songs, and ultimately they managed to develop a strong bond. As part of the special programmes for the elderly, the Santhwana team conducted a training programme for the elderly on yoga and dealing with ageing-related health issues. Simple yoga steps that help to keep the body and mind calm were demonstrated during the session and common ageing-related health issues and methods to cope with them were also discussed during the programme.



## Mental Health Week

ESAF commemorated Mental Health Week, as part of the Santhwana Project, with the intention of generating mental health awareness among the general public. As part of the

commemoration, the Santhwana team conducted a series of sessions and competitions for school students.

ESAF organized three online sessions on mental health literacy during Mental Health Week. The first session was organized on 9<sup>th</sup> October 2021 with the participation of 21 Women Resource Persons from ESMACO, the second session

was conducted on  $10^{th}$  October 2021 with the participation of 33 differently-abled children, and the third session was on  $13^{th}$  October 2021 with the participation of ESAF Sangam members.

## Competitions abla

On the theme of Mental Health Week, ESAF conducted competitions for school children on speaking, colouring, and drawing. 285 students from 10 schools attended the competitions. The successful students were awarded certificates and trophies.

As part of the ESAF Santhwana project, the project team prepared IEC materials like posters & bookmarks, on different themes and distributed them to the public through ESMACO and ESAF bank's branches. The themes included in the IEC materials were myths and facts related to mental illness, how to promote mental health, BYE BYE to stress, Addiction-Help, and Signs of mental ill-health.

## Digital Magazines 🔨



Removing the public's stigma around mental health is one of the most important aspects of the Santhwana Project. The project team focused on spreading awareness on mental health issues, ways to reduce stress and ways to strengthen the mind to cope with uncertain situations. In the year 2021-22, 6 magazines were prepared and circulated through online platforms. The themes of the digital magazines included understanding the needs of adolescents, building resilience, managing personal finance, suicide prevention, and children's education & you (Kuttikalude Padanavum Ningalum).

## Life Skill Training

The future of the nation depends on the quality of life of its children. Life skill training for children helps to improve their cognitive capacities and equips them to cope with unpredictable situations in life. In this regard, ESAF conducted 10 life skill training sessions (4 online & 6 offline sessions) for school children across Kerala.

K. Paul Thomas, Founder, ESAF Group of Social Enterprises, inaugurated the dedication function. Smt.Mereena Paul, Executive Director, ESAF Foundation, Dr. Jacob Samuel, Director, ESAF Foundation blessed the occasion. As part of the function, the newly renovated block of the hospital was inaugurated by Shri. K. Paul Thomas. Important national days like Nurses Day, Independence Day, World Environment Day etc. were celebrated during the reporting period.

## Activities 🔨

#### **Educational Support**

Amidst the covid-19 pandemic, one of the groups that were severely impacted was school-going children. Schools were shut temporarily and they began to rely on online classes but an unavoidable number of children went out of the system due to the unavailability of digital gadgets (Smartphones, tablets, televisions, computers, laptops, etc.), in this connection, with the support of ESAF Small Finance Bank, ESAF started supporting the needy children with the required devices. In the year, ESAF supported 136 children with smartphones, televisions, and tablets.





#### **Covid-19 Vaccinations**

As part of the emergency relief intervention programme, ESAF supported the Government in organising Covid-19 vaccination drives in remote areas. Through the programme, ESAF provided logistical support to the tribals, women, elderly, differently-abled, and other vulnerable communities to reach the vaccination centres and also brought the health workers to the interior villages for supplying vaccines to the unreached. 8,636 people were vaccinated through this intervention. Attappady, Idukki, Wayanad, Athirappilly, and Sholayoor were the major areas to which ESAF extended its support.

#### **Relief Kits**

When the pandemic and the natural calamities hit the people, ESAF supported the families with relief kits. 2,733 families were supported with food kits, blankets, etc.





#### **Medical Camps**

ESAF has organized medical camps for the general public with the support of ESMACO and LLMS in Kerala, Tamil Nadu, Karnataka, Bihar, Jharkhand, West Bengal, Tripura, and Assam. Through the medical camps, ESAF could reach 6,038 individuals.

ESAF supported the Kuthampully weavers in marketing their products and rejuvenating their weaving technologies. Through the programme, ESAF supported 400 weavers from the Kuthampully weaving communities.

## IHT – Rural Hospital infrastructure – Thachampara 🦷 🥆

#### **Hospital Renovation**

ESAF Hospital and Research Centre, Thachampara, offers affordable medical care to the rural population. During the pandemic, a Covid ward was established and the same was upgraded by providing a centralized supply of oxygen that replaced the manual supply. This proved to be a solace for the rural populace as they began to get better medical facilities. The infrastructure renovation was one of the key priorities and it was done with great detailing. As part of the renovation, tile works in the surgeon room, storeroom, passage, water tank area, eye clinic OP, rooms, and toilets, were executed apart from painting, and plumbing works. Ultimately, the rural population became the winners as they began to enjoy better healthcare facilities.

#### **Medical Equipment**

As part of renovating the ESAF Hospital and Research Centre, medical equipment was supplied to the hospital. The list of equipment is given below.

## Results (Outcomes and Impacts) abla

> Supported 2773 families during emergencies through the distribution of relief kits.

▶ With the support to Amala Institute of Medical Sciences, Thrissur 137 COVID affected patients were given isolated treatment through 10 ICU beds.

▶ The neonatal monitor at the Morning Star Medical Centre, Adimali helped to improve the health of 22 neonatal babies and through the Vacuum extractor enabled to avoid 6 cesareans sections.

> Through critical ventilator supported to Jubilee Mission Hospital, Thrissur 93 COVID patients were treated.



## Case Studies 🔨

#### Suraksha -2021

Suraksha-21 was conceived at a time when India was reeling under the public health crises of Covid-19 across its length and breadth. Only 5% of the population were vaccinated against Covid, and vaccine hesitancy was becoming detrimental to India's fight against Covid. Taking up the mantle to arrest vaccine hesitancy and provide vaccination, especially to the poor, marginalised and vulnerable people groups, ESAF designed Suraksha-21 Covid Response Project partnering with Opportunity International Australia. A three-phased strategy was designed with the motto "No one is safe until everyone is safe" to educate the community on vaccination and organise vaccination drives with the support of the Health Department and the Local Government Bodies.

1. Covid Suraksha Awareness Programme (CSAP) -Community leaders were trained to be health educators by organising COVID awareness sessions. Awareness materials were published in the vernacular languages to reach out to the community. The sessions were organised to counter misconceptions and arrest vaccine hesitancy.

2. Covid Suraksha Vaccination Camps (CSVC) - Assisted the Health Department and Local Government Bodies in organising vaccination camps at the community level.

7 states | 2021 vaccination camps | 7,23,817 vaccines administered

3. Covid Suraksha Mobile Vaccination Unit - The Mobile Vaccination Unit brought vaccines to the people groups in the hinterlands where the state machinery was not equipped to host vaccination camps. Tribal people, pregnant women, palliative care patients, and persons with physical and mental disabilities were provided with vaccines through the Mobile Vaccination Unit.
